This has reference to your application dated 01.09.2011 in Tier II format seeking accreditation by National Board of Accreditation to the UG Engineering programmes offered by Poornima College of Engineering, ISI-6, RIICO Institutional Area, Sitapura, Goner Road, Jaipur, 302 022, Rajasthan.

2. An Expert Team conducted on-site evaluation of the programs during 18th to 20th March, 2016 and 7th May, 2016. The Report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The competent authority in NBA has approved the accreditation status to the programs as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted Provisional Accreditation for 2 years. As such Poornima College of Engineering, ISI-6, RIICO Institutional Area, Sitapura, Goner Road, Jaipur, 302 022, Rajasthan is required to submit the Compliance report after 18 months. It may require submission of pre-qualifier before sending the Compliance report for granting further Accreditation. The process for submitting Pre-Qualifiers and Compliance report has been notified on the website of National Board of Accreditation.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to Poornima College of Engineering, ISI-6, RIICO Institutional Area, Sitapura, Goner Road, Jaipur, 302 022, Rajasthan as a whole. **As such, the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of programs and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
6. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of your Institute.
7. The accreditation status awarded to the programs as indicated in the table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.

9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
